*Determinants of pathogenesis of Erwinia amylovora on host plants and elicitation of the hypersensitive response (HR) on non-host plants were studied. The ability of E. amylovora to cause fire blight and to elicit the HR requires hrp genes. These genes encode a protein secretion system, regulatory elements and secreted proteins (e.g. harpin). Protocols to purify the harpin of E. amylovora were developed. Portions of harpin required for HR-elicitation and for secretion were identified by expression of truncated proteins and of fragments of harpin derived by proteolysis. Two distinct non-overlapping peptide fragments of harpin retained HR-*

*eliciting activity on tobacco. Multiple apoplastic proteinases that proteolyze harpin without abolishing HR-eliciting activity were identified. In nature, most strains of E. amylovora cause fire blight on members of the Pomoideae (e.g. apple and pear), while others cause disease on Rubus spp. Greenhouse and laboratory tests demonstrated that representative strains originally isolated from either Pomoideae or from Rubus spp. can cause fire blight symptoms on both pomaceous hosts and on Rubus spp. The hrp gene cluster of E. amylovora strain Ea246, a pathogen of Rubus spp., was cloned on cosmid pCPP460, and compared with the previously isolated hrp gene cluster present on cosmid pCPP430 of E. amylovora strain Ea321, a pome-fruit pathogen. The structure and function of the hrp-secreted HR-eliciting proteins, harpin<sub>Ea</sub> of Ea321 and harpin<sub>Ea246</sub> of Ea246, were studied. For these two strains, neither harpins nor hrp gene function were found to determine host range or virulence toward specific hosts. Because production of "active oxygen" molecules is an important part of the plant defense response, a putative role for catalase, a hydrogen peroxide-detoxifying enzyme, also was studied. A gene of Ea321 encoding catalase was cloned and mutagenized, and marker-exchanged into two wild-type strains of E. amylovora. The catalase-deficient strains were pathogenic on host plants, with little change in*

virulence. A search for a harpin-like protein from *Xanthomonas campestris* pv. *glycines* proved unsuccessful.
